("Claims"). I hereby agree accept full responsibility and hold blameless the Club, its members, agents, and representatives, or the owner of the property where the trial is held. This includes all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program. In consideration for being allowed to attend, I agree to indemnify and hold harmless the Club, from all liability or claims of any nature by myself, my guests and family members. *

By submitting the registration form you are agreeing to the following waiver

We (I) agree that the club holding this event has the right to refuse this entry for cause which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry, the holding of this event and the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and employees, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death of otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the aforementioned, or by the negligence of any other person, or any other cause or causes.
